



SUMMER WORKSHOP LIABILITY WAIVER AND PHOTO RELEASE AGREEMENT

In consideration of being permitted to participate in the Bill T. Jones/Arnie Zane Company Summer Workshop (June 3-8 2024) I hereby waive, release and forever discharge the Bill T. Jones/Arnie Zane Company and its principals, officers, directors, agents, insurers and employees from liability from any and all claims, actions and causes of action (including resulting from negligence) that may at any time result from my participation in the Workshop, including any such that relate to costs, expenses or damages to my personal property or for personal injury or illness (including death).

I confirm that I am over 16 years of age. I am in good health, physically fit and do not have any injury or disability which might jeopardize my participation in the Workshop. I agree not to reproduce, teach or perform any repertory learned. All choreography is subject to copyright and licensing agreements.

I confirm that my participation in the Workshop is voluntary. I assume all risks of any damage, injury or disability to my person or property that may occur as a result of my participation in the Workshop. I acknowledge that I will be solely responsible for any and all costs and expenses that I may suffer as a result of my participation in the Workshop. I hereby give up any right that I might otherwise have to sue for injury or damages resulting from my participation in the Workshop. By signing below, I confirm that I have read and accepted the conditions to my participation in the Workshop as set forth above. I understand that I am giving up substantial rights including the right to sue.

I understand that participant refunds will only be considered by written cancellation and where necessary a doctor's note must be provided. A non-refundable \$250 workshop fee deposit is the responsibility of the participant in all cases. I further understand that Bill T. Jones/Arnie Zane Company and New York Live Arts has the right to cancel the intensive for any reason deemed necessary including factors beyond their control. Cancellation of the event on the part of Bill T. Jones/Arnie Zane Company and New York Live Arts will result in my being refunded the full amount of payments-to-date, of all tuition. Additional costs such as travel and accommodation will not be refunded.

I give full permission to Bill T. Jones/Arnie Zane Company and New York Live Arts to photograph and/or video me and my property in connection with the intensive for promotional material, educational purposes or any other use. I agree not to video or photograph classes, rehearsals or performances without prior permission, which, if granted, will be for personal use only. Posting any video footage or photos of class, rehearsal or performance is strictly prohibited.

BY REGISTERING AND PAYING FOR ANY CLASS, INTENSIVE, EVENT, PRIVATE LESSON, OR OTHER ACTIVITY, YOU ARE AGREEING TO ALL OF THE ABOVE CONDITIONS AND WAIVERS.

NO ONE WILL BE ABLE TO PARTICIPATE IN ANY CLASS OR EVENT UNLESS YOU ACCEPT AND AGREE TO ALL OF THE TERMS IN THIS AGREEMENT.
